**Kid Connection – Parent Agreement**

1. Parent agrees to contact Kid Connection at (772)287-1779 in the event of their child's unexpected or extended absence. Contact must be made prior to 1pm.
2. Parent agrees that if their child has a temperature of 100° or more he/she should not be returned to Kid Connection until free of the temperature for 24 hours. Should their child be sent home from school or aftercare with fever, diarrhea, or vomiting, he/she must automatically take the next day off.
3. Parent also agrees to notify Kid Connection in the event of a contagious illness and keep their child away from aftercare until the danger of contagion is past.
4. Parent agrees that in all emergencies, the center has permission to take such reasonable measures that are, in the judgment of the center, necessary to the welfare and safety of all the children.
5. The parent agrees to notify Kid Connection of any problems that arise at home that may affect their child at aftercare (i.e. separation or divorce of parents, death in family, etc.).
6. Parent agrees that in the case of extreme behavioral issues, the parent or guardian will be notified and asked to remove their child from aftercare for the remainder of the day. The child will not be able to return until arrangements have been made between the parent(s) and the Director.
7. The center reserves the privilege of dismissing any child if he/she seems unable to participate in group activities, exhibits continual disruptive behavior, or has a delinquent tuition account.
8. The Kid Connection agrees to exercise reasonable care and judgment in all matters related to the welfare and safety of the children in the center.
9. The Kid Connection agrees to notify parents as soon as possible in the case of severe accident or illness. If an accident or illness occurs that requires medical attention and parent cannot be reached, 911 will be called.
10. The Kid Connection will provide an afternoon snack.

11. Kid Connection agrees that the following procedures will be used for disciplinary action:
  - a. Separation from the group for a short period
  - b. Loss of privilege/activity/or reward
  - c. Note home to parents
  - d. Parent called to remove child
  - e. Corporal punishment is never used.
  
12. Kid Connection agrees to provide care each school day afternoon, on early release day afternoons, and (for an additional fee) on selected out-of-school days known as "Celebration Days." Kid Connection will also offer care for select days over Christmas Break and Spring Break.
  
13. Kid Connection agrees to provide all day care on selected out-of-school days, so long as the attendance deems the care necessary.
  
14. Kid Connection will be closed for holidays as follows: Labor Day, two days at Thanksgiving, two days at Christmas, New Year's Day, Good Friday and Memorial Day. Please see the Kid Connection Aftercare Calendar of Events for specific dates.
  
15. Kid Connection agrees that there will be no additional charge for pick up on early release days. We provide the extra time on these early release day for no additional charge. Consequently, the week of Thanksgiving will be charged at the full weekly rate to offset the cost of the extra time on early release days.
  
16. Kid Connection agrees to provide accident insurance coverage.
  
17. Kid Connection agrees not to release the child to anyone other than the parent or guardian, unless written permission is given.
